# ARTICLES OF INCORPORATION OF CALVARY COMMUNITY CLINIC, INC.

14 JUN 27 PM 4: 25 SECRETATY OF STATE TALLAHASSEE, FLORIDA

The undersigned, acting as the incorporator of Calvary Community Clinic, Inc., adopts the following Articles of Incorporation pursuant to Chapter 617 of the Florida Statutes.

#### ARTICLE I NAME

The name of this corporation shall be 'Calvary Community Clinic, Inc.' (the "Corporation").

# ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

The street address of the initial principal office of the Corporation shall be 4902 N. 40<sup>th</sup> Street, Tampa, Florida 33610, and the mailing address of the Corporation shall be 4902 N. 40<sup>th</sup> Street, Tampa, Florida 33610.

# ARTICLE III REGISTERED AGENT AND REGISTERED OFFICE

The name of the Corporation's registered agent is Marcellina Adonis. The street address of the initial registered office of the Corporation is 4902 N. 40<sup>th</sup> Street, Tampa, Florida 33610.

#### ARTICLE IV PURPOSE

This Corporation is a not-for-profit corporation organized under Chapter 617 of the Florida Statutes and shall be operated exclusively for charitable and educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States internal revenue law (the "Code"), and not for pecuniary profit. Within the scope of the foregoing, the Corporation is specifically organized to: (i) provide health services at no charge to low-income, uninsured and underserved people using volunteer health professionals and community partnerships, and (ii) engage in such other activities as are necessary, appropriate, or convenient to the furtherance of the foregoing stated purposes and permitted under the laws of Florida and the United States.

#### ARTICLE V LIMITATIONS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its Directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes.

#### ARTICLE VI BOARD OF DIRECTORS

The affairs of the Corporation shall be governed by a board of directors (the "Board") consisting of at least a minimum of three (3) directors ("Directors") at all times. The number of Directors of the Corporation shall be established in the bylaws of the Corporation (the "Bylaws"); provided however that, in accordance with the above provision, the number of Directors shall never be less than three (3). The qualifications to serve as a Director, the terms for which each Director shall serve, the rights and powers of the Board, and the manner and selection of the Board shall be as specified in the Bylaws.

#### ARTICLE VII MEMBERSHIP

The Corporation shall have no members.

## ARTICLE VIII DISSOLUTION

In the event of the dissolution of the Corporation, the Board shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, distribute, all of the assets of the Corporation to one or more organizations that qualify for exemption from federal income tax as organizations described in Section 501(c)(3) of the Code or the corresponding section of any future United States internal revenue law, as the board of directors shall determine. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
