

ARTICLES OF INCORPORATION OF COMMUNITY ACTION PROGRAM SERVICES CORPORATION

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

First: The name of the Corporation shall be COMMUNITY ACTION PROGRAM SERVICES CORPORATION

Second: The place in this state where the principal office of the Corporation is to be located is 331 Church Street, Deland, FL 32724, Volusia County.

Third: Said Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
