Thank you for taking my phone call earlier this morning. Again, my firm represents the interests of Fulfilling Endeavors Incorporated regarding its attempt to form a not-for-profit corporation in the state of Florida. The purpose of this letter is to confirm for Florida's Secretary of State that, for the reasons stated below, there is no conflict in assigning this proposed corporate name to my client.

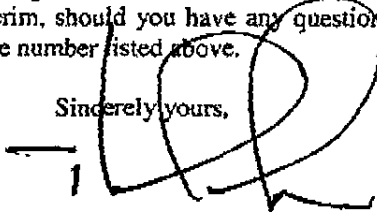
By way of brief review, the name "Fulfilling Endeavors, Inc." is a name for a dissolved Tennessee not-for-profit corporation that first registered to do business in the state of Florida in 2009. (See Doc. No.: F09000000130; and FE/ EIN No.: 205521267). In September, 2013, this corporation was administratively dissolved. As of the date that this entity was dissolved, Nathan C. Bell served as the corporation's Incorporator, Registered Agent and President.

As it relates to this request, Mr. Bell now seeks to form a new Florida not-for-profit corporation by the name of "Fulfilling Endeavors Incorporated". Please allow this letter to confirm that Mr. Bell in his capacity as the Incorporator and officer for the dissolved Tennessee corporation has no interest in re-instating, re-opening, or re-registering the Tennessee corporation in the state of Florida. Rather, it is his desire to open a new corporation under a different, but certainly similar corporate name.

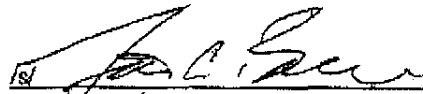
