Article III: The specific purpose for which this corporation is organized is:

(A) St. Augustine High School Cambridge Advanced International Certificate of Education Booster Club, Inc. (hereinafter "AICE Booster Club")
is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of
distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internat Revenue Code, or
corresponding section of any future federal tax code. The AICE Booster Club supports the education of children
in the Cambridge Advanced International Certificate of Education program (hereinafter "AICE") at St. Augustine
High School (hereinafter "SAHS") by fostering relationships among the school, parents, teachers and AICE students. The objectives
of the organization shall be: (1) To promote the welfare and education of AICE students at SAHS; (2) To work with the administration
and teachers to raise the standards of academic excellence and the quality of the educational environment for both the students
and teachers involved in the AICE program at SAHS; (3) To provide avenues for communication between parents, teachers,
administration and AICE students at SAHS; (4) To provide resources for the purpose of educating AICE students and promote
the further education of current AICE students. (B) Upon the dissolution of the AICE Booster Club, assets shall be distributed
for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding
section of any future federal tax code, or shall be distributed to the federal government, or to a state or local
government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent
Jurisdiction of the County in which the principal office of the organization is then located, exclusively for
such purposes or to such organization or organizations, as said Court shall determine, which are organized
and operated exclusively for such purposes.
