Amended Article III

Said corporation is organized exclusively for charitable and educational purposes, including for such purposes as the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, of the corresponding section of any future federal tax code. The specific purpose is to support the athletes and coaches participating in the High Springs Hawks Football Association program, as well as the league, through an organization of interested parents and local individuals. The organization is to support fair and ethical athleticism of the football program as so designated, provide financial support to the organization and ensure disbursement of collected funds to benefit that program and to ensure adherence to established ethical standards and behavior in all related activities. The organization supports the sport of football league for those players in the appropriate and designated age group for grades sixth through eighth of the local public school system. This local area is known for sponsoring competitive sporting events at the national competitive level for players of this age group and will continue to do so.

Amended Article VIII

The effective date of this corporation is to be:

July 14, 2014. During the first operational year, the accounting and tax reporting year shall begin with the organizational date and end April 30, 2015. Thereafter for each and every subsequent year, the accounting and tax reporting year shall being May 1 and continue to end on April 30 of the following calendar year.

Article IX

No part of the net earnings of the corporation shall inure to the benefit of, distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article X

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
