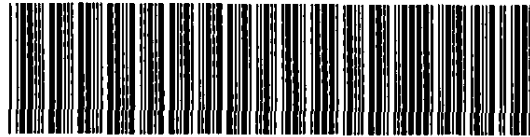

**ARTICLES OF INCORPORATION
FOR

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, and desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

ARTICLE IV PURPOSE(S)

Said corporation is organized exclusively for charitable, educational, scientific, and fostering national and international amateur sports competition purposes, including for such purposes as, making distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Furthermore, the organization will promote technical and good sportsmanship development of referees, instructors, and athletes alike. It will service the judo and other related martial arts disciplines by organizing, promoting, and supporting amateur competition, educating the public, and encouraging the involvement of families and students. Finally, it will sponsor cultural and historical exchange across different martial arts disciplines.

ARTICLE VIII EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Fourth hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes






