



ARTICLES OF INCORPORATION OF



NATIONAL COLLECTION OF VISUAL ARTS, INC. A NONPROFIT CORPORATION

The undersigned natural person of the age of eighteen years or older, acting as incorporator for the purpose of creating a nonprofit corporation under the laws of the State of Florida in compliance with Chapter 617, F.S., do hereby set forth:

Article I The name of the corporation is **National Collection of Visual Arts, Inc.**

Article II The principal place of business and mailing address of this corporation is:

3713 Pine St.

Jacksonville, FL 32205

Article III The purpose for which the corporation is organized are:

- a. National Collection of Visual Arts, Inc. is organized for exclusively religious, charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law, including, for such purposes, the making of distributions to organizations that qualify as exempt under said Section 501(c)(3) of the Internal Revenue Code of 1986. Specifically, the organization shall engage in the practice of accepting contributions of all unique and historical artifacts and collectibles that have been traditionally been difficult for many 501(c)(3) organizations to accept.
- b. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- c. No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaigns on behalf of any candidate for public office.
- Article IV The board of directors of the corporation shall be elected or appointed in the manner and for the terms provided in the Bylaws.

Article VII The corporation will not have members.

Article VIII No part of the net earnings of the corporation shall inure to the benefit of any officer or director of the corporation; and upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of the residual assets of the corporation exclusively for exempt purposes of the corporation in such manner, or to one or more organizations which themselves are exempt as organization described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding Sections of any future Internal Revenue Code. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, for such purposes or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
