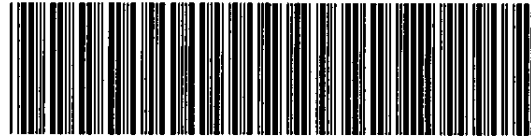

In order to correct a scrivener's error, subsection (a) of Article IV is hereby amended to read as follows:

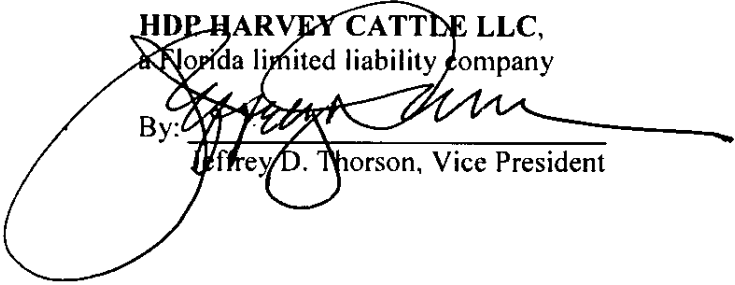
(a) exercise all powers authorized by Chapters 617 and 720, *Florida Statutes*;
