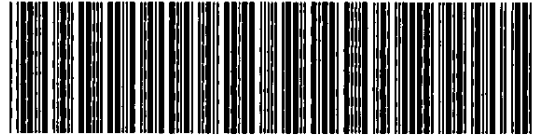

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation is:
Mary Mother of Jesus Inclusive Catholic Community, Inc.

ARTICLE II

ARTICLE III

The specific purpose for which this corporation is organized is:

Mary Mother of Jesus Inclusive Catholic Community exists to provide weekly worship in the Roman Catholic tradition, providing Catholic sacraments and rituals for all who come to our liturgies. All are welcome to receive sacraments including those who are on the margins of our church and society. We provide educational and action opportunities in faith and justice making in the Catholic tradition and ministry opportunities such as providing services for those who are homeless. We partner with St. Andrew United Church of Christ in Sarasota, Florida and volunteers from that church; volunteers from Call to Action of Southwest Florida, Inc. (Roman Catholic); and other volunteers with a variety of religious affiliations including Roman Catholic, Muslim, Methodist, and Evangelical backgrounds. Our belief is that people of faith, joining together can minister to and with people of God who are experiencing crises and stress due to poverty, unemployment, the lack of affordable housing. Together we work toward empowerment and the building of a community of caring and service.

The purposes for which Mary Mother of Jesus Inclusive Catholic Community is organized are exclusively religious, charitable, and educational within the meaning of section 501(c)3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law. Notwithstanding any other provision of these articles, Mary Mother of Jesus Inclusive Catholic Community shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501(c)3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law

Article IV

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article V

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


