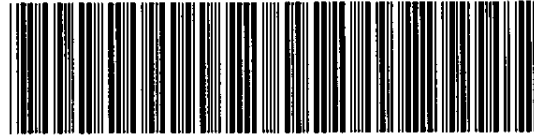

**ADOPTION OF DISSOLUTION**


The corporation has no members entitled to vote on the dissolution. The number of directors in office was three and dissolution was approved by a vote of three in favor of dissolution and zero against.
