The undersigned are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

ARTICLE I

Name

The name of the Corporation shall be BAM Festival Inc.

ARTICLE II

Principal Office

The principal office of the Corporation is to be located at 13617 41st Lane North, City of West Palm Beach, County of Palm Beach, State of Florida.

ARTICLE III

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

The names and addresses of the persons who are the initial trustees of the corporation are as follows:

ARTICLE V

Purpose

- A. The corporation purpose is to provide a countywide literary experience bringing together authors, teachers, students, families and the community to share their love of books. The signature event is the authors' festival featuring authors who write for children and young adults. The event also consists of art and music elements, including street painting and live music.
- B. The corporation, through its members, shall endeavor to secure funds by donations, bequests, subscriptions, and other suitable and appropriate means, and to expend such funds in the support of the objects hereinafter stated, in a manner consistent with appropriate federal and state laws.
- C. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.
- D. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
- E. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

ARTICLE VI

Membership

Membership in this corporation shall be open to all individuals who support the purpose of the corporation and who are approved and accepted into membership by a majority vote of the directors of this corporation.

The initial officers will serve as the first officers of the corporation. The initial board members, of no less than three (5) and no more than (15) will be appointed unanimously by the initial Executive Committee at their first meeting. The initial Executive Committee and appointed board members will serve staggered terms to be determined by mutual agreement. After initial organization, elections for corporation officers and Board of Directors will occur as set forth in the bylaws.

ARTICLE VIII

Corporation Officers and Their Functions

The general officers of the corporation shall be President, Vice-President, Secretary, and Treasurer.

President shall preside at all meetings of the corporation and have general supervision of the affairs of the corporation.

Vice-President shall be to discharge the duties of the president in the event of absence or disability, for any cause whatsoever, of the president.

Secretary shall keep all records of the corporation, including minutes of corporation meetings, and correspondence as directed by the president. If needed, shall countersign all leases and conveyances executed by the corporation. The secretary shall file annually any documents required by the State of Florida.

Treasurer shall keep an account of all monies, credits and property of any and every nature of the corporation which shall come to the corporation, to keep an accurate account of all monies received and disbursed and of proper vouchers for monies disbursed, to render such accounts, statements and inventories of monies received and disbursed, and generally all matters pertaining to the office as required by Officers and the Board of Directors.

The officers may provide for the appointment of such additional officers as they may deem necessary for the best interest of the corporation.

The officers shall perform additional or different duties as shall from time to time be imposed or required or as may be prescribed from time to time by the bylaws.

ARTICLE IX

Bylaws

The Officers of the Corporation shall prepare the bylaws of this corporation. After the original set of bylaws have been approved, they may be altered, amended or rescinded by a two-thirds vote of the Officers of the Corporation and Board of Directors.

ARTICLE X

Amendments

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation. The method and manner of amendment shall be governed by the laws of the State of Florida and the Bylaws of this corporation.

ARTICLE XI

Distribution of Assets Upon Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
