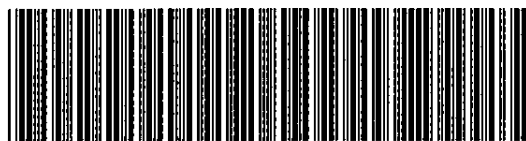



Article VIII Distributions Upon Dissolution
