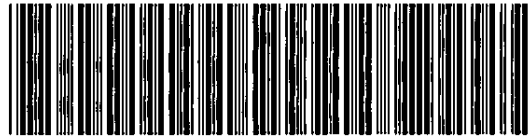

Article I.

Article III.

The purpose of for which T4G Mentorship, Inc. is organized is:

Section III.01 To operate exclusively for charitable, educational and religious purposes within the meaning of Section 501(c) 3 of the Internal Revenue Code of 1986, or corresponding section of any future tax code and generally to engage in any other lawful endeavor or activity in the furtherance of any of the foregoing purposes.

Article IV.

The manner in which Directors are elected is:

Section IV.01 Election and Tenure. The Initial Board of Directors shall be appointed by the incorporators and thereafter shall be elected by the Board of Directors at a regular meeting of the Board of Directors, to be held at the principle office of T4G Mentorship, Inc. or such other place, as may be fixed by the Board. Directors who are elected shall serve for a term of one (1) year or until his or her successor is elected and qualifies, subject however to the removal of any Director as allowed by applicable law or T4GMentorship, Inc.'s Bylaws.

Section IV.02 Election: Nominating Committee. A Nominating Committee shall prepare a slate containing nominees for each board position and shall determine the eligibility and willingness of each nominee to stand for election. Candidates for Board positions may also be nominated by a petition process established by the Nominating Committee or the Board.

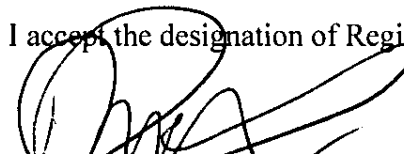

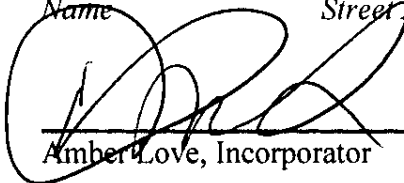

The provision regarding liabilities for breach of duties is:

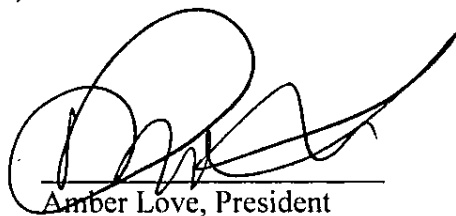
