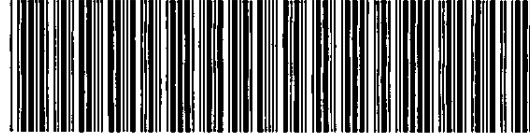

By Laws Section 3: Purposes 3.01
