ARTICLE I: NAME OF CORPORATION

The name of the Corporation shall be, **VITAL SOLIDARITY/SENTIDO VITAL INC.**

ARTICLE II. PRINCIPAL OFFICE

The principal address of the Corporation is : 14213 SW 94 Circle Lane 8-101, Miami, FL 33186.

ARTICLE III. PURPOSE

The Corporation is organized exclusively for charitable , educational and social purposes, including , for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(d)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, in addition, the main purpose of this Non Profit Corporation, is to serve our community by supporting those who have suffered losses and have been affected in their physical, mental, spiritual and emotional stability; helping them cope with their pain and overcome their limitations and achieve the social stability they need, through seminars, workshops, conferences, educational materials and clothing and food assistance to families who required it.

ARTICLE VI. Limitations

This Corporation, is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the net earnings of VITAL SOLIDARITY/ SENTIDO VITAL INC. ,shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VII. Dedication of Assets

No officer or director of this corporation shall be personally liable for the debts or obligations of VITAL SOLIDARITY/ SENTIDO VITAL INC ,of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

Upon termination or dissolution of the VITAL SOLIDARITY/ SENTIDO VITAL INC , any assets lawfully available for distribution shall be distributed to one or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code (or described in any corresponding provision of any future tax code) or shall be distributed to the Federal government or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is then located, as said Court shall determine which are organized and operated exclusively for such purposes.
