ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION of WEST FLORIDA HEALTH, INC. (Document No. N14000007256)

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, West Florida Health, Inc. (the "Corporation") adopts the following amendments to its Articles of Incorporation:

- .1. Text of Amendments.
 - A. Article III is deleted in its entirety and substituted with the following:

ARTICLE III Purpose

The Corporation is organized and shall be operated exclusively for charitable, educational and scientific purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code (the "Code"), including, but not limited to:

- (A) expanding the availability of professional medical services to residents and visitors of West Florida; and
- (B) promoting public health and foster related activities that are consistent with the scientific, educational and charitable purposes of each Member and support of the interests and purposes of the Corporation described in this Article.

Except as limited under Article XI of these Articles, the Corporation shall have all powers now or hereafter granted by law and, in addition thereto, shall have all powers lawfully necessary or required to carry out its purposes and objects.

B. Article IV is deleted in its entirety and substituted with the following:

ARTICLE IV Members

The initial Members of the Corporation are:

The qualifications of members and the manner of admission of new members shall be as specified in the bylaws of the Corporation.

- Date of Adoption. The Amendment was adopted on October 1, 2014. 2.
- Manner of Adoption. The Amendment was adopted by the written consent of the Members, and the numbers of votes cast in favor of the Amendment was sufficient for approval.
