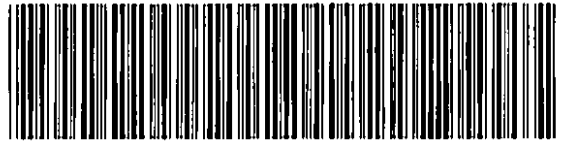

**ARTICLES OF AMENDMENT  
to  
ARTICLES OF INCORPORATION  
of

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, West Florida Health, Inc. (the "Corporation") adopts the following amendments to its Articles of Incorporation:

1. Text of Amendments.

A. Article IV is deleted in its entirety and substituted with the following:
