Articles of Amendment

E. Additional Articles

Article 3 (PURPOSE) is removed and replaced with the following: The corporation is organized exclusively for the purpose of advancing, supporting and developing amateur athletes for national and international competition in a variety of sports by providing a means to obtain elite athletic training, sport specific instruction and mentorship. The program will focus on two types of people: (a) athletes who demonstrate a high level of athletic ability and achievement, but who don't have the financial means to obtain the advanced training necessary to fully develop their skill, ability, and knowledge of their chosen sport, and (b) athletes who lack the general fitness education necessary to either excel in a particular sport or to maintain their general heath and well-being. Those groups of people are more prone to quitting their training before they can get to the level where their chosen sport helps develop them socially and emotionally and, ultimately, provides a path to a scholarship for a college education. The program will pay for the cost of intensive, daily training, nutritional advice and sport specific education and will conduct the fundraising necessary to finance and support those activities.
