

ARTICLE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF TOWNHOMES OF WEST LAKE COMMUNITY ASSOCIATION, INC.

Adopted amendment to Paragraph 4 of the Articles of Incorporation of Townhomes of West Lake Community Association, Inc., to read as follows:

4. Definitions. The COMMUNITY DECLARATION FOR TOWNHOMES OF WEST LAKE (the "Declaration") will be recorded in the Public Records of Hillsborough County, Florida, and shall govern all of the operations of a community to be known as TOWNHOMES OF WEST LAKE.
