

The Florida Multicultural District of the Assemblies of God, Inc. and/or the General council shall have full authority to sell such property and to use the proceeds derived there from for the extension of the work of the Florida Multicultural District Council of Assemblies of God specially those churches that this corporation may have established as churches and or ministries.
