ARTICLES OF INCORPORATION of CLAY COUNTY EDUCATION ASSOCIATION, INC. A Non-Profit Corporation

The undersigned subscribers of these Articles of Incorporation, being natural persons comment to contract, hereby subscribe to and forma cooperation not for profit under the laws of the State of Florida.

ARTICLE I Name and Principal Office

The name of the corporation is CLAY COUNTY EDUCATION ASSOCIATION, INC, a Non-Profit Corporation, and it shall have as its principal address 2823 Bolton Road, STE 101, Orange Park, Florida, 32073 and as its mailing address 2823 Bolton Road, STE 101, Orange Park, Florida, 32073.

ARTICLE 11 Duration

The corporation is to exist perpetually, with commencement at the time of filling these Articles.

ARTICLE III Purpose

The purpose or purposes for which the corporation is organized are:

- Clay County public school teachers joining together for the mutual enhancement of their professional and educational needs. Such purposes included benevolent, educational, political, and social matters.
- To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act, or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing non-profit organization.
- 3. Further the corporation is to be operated exclusively for those purposes allowed an exempt organization within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1954, 19886 or the corresponding provision of any future United States Internal Revenue law. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1954, 1986 or at the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV Qualification

Any person evidencing a willingness to work toward the goals of the organization as set forth in its Bylaws may be accepted to regular membership on approval of the Board of Directors.

ARTICLE V Registered Agent and Address of Registered Office
