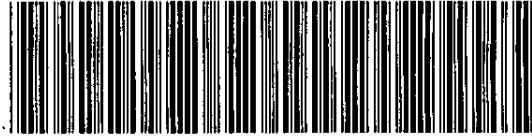

Pursuant to the provision of section 617.1006, Florida Statutes, this Florida Not for Profit Corporation adopts the

following amendment(s) to its articles of incorporation.

FIRST: AMENDMENTS ADOPTED- (OTHER THAN NAME CHANGE).

Article 1X: - Insert Paragraphs 10-14.

#10 -The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law

#11: - No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause

#12:- In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c) (3) and 170 (c) (2) of the Internal Revenue Code or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

#13 -No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the organization shall not participate in or intervene in (including the publishing or distribution of) any political campaign on behalf of any candidate for public office.

#14- Notwithstanding any other provision of this document, the organization will not carry on any other activity not activity not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code.

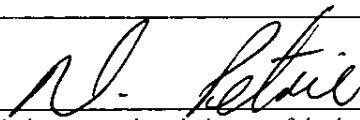
