Article 1X: - Insert Paragraphs 10-14.
#10 -The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary and
educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding
provision of any future United States Internal Revenue Law
#11: - No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees,
officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compens
for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause
#12:- In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations
