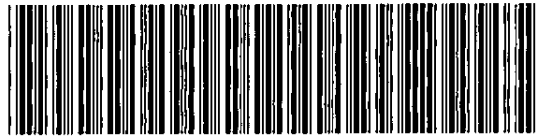

The manner in which directors are elected or appointed is by majority vote of the Board of Directors or as provided for in the Bylaws.

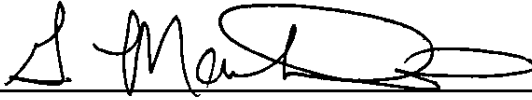

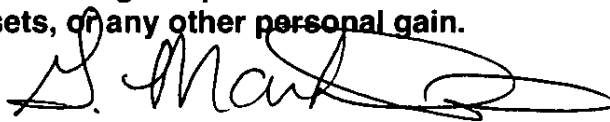
