ARTICLES OF INCORPORATION SECRETARY OF STATE TALLAHASSEE RECORDA

ARTICLE 1.- NAME OF CORPORATION:

The name of the corporation is Refreshing Springs Ministries, Incorporated.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III.- PURPOSE OF THE CORPORATION:

As set forth in the Articles of Incorporation, Refreshing Springs Ministries has been formed for the following purposes:

- 1) To provide a place and means for religious fellowship and prayer for its members
- 2) To practice the dissemination of the Christian religion both local and/or national
- 3) To engage in and carry on all kinds of missionary work
- 4) To publish religious literature

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE V - MANNER OF ELECTION

The officers of this corporation shall be appointed by the President or elected by a majority vote of the members of this corporation.
