

ARTICLES OF INCORPORATION Ministerio Cristiano Nuevo Comienzo, Inc.

ARTICLE I: NAME

The name of the corporation shall be: Ministerio Cristiano Nuevo Comienzo, Inc.

ARTICLE II: PRINCIPAL AND MAILING ADDRESS

ARTICLE III: PURPOSE

The purpose for which this corporation is organized is: This corporation is a nonprofit religious corporation and is not organized for the private gain of any person. Our purpose is to proclaim Christ, to bring people to know him, to take Christ into the world, to provide a place for public worship, religious training and education where this can occur, and to otherwise encourage and aid the growth, nurture, and spread of the Christian religion, and to render Christian service, both material and spiritual to the sick, the aged, the homeless and the needy, as the Lord directs. In carrying out such purposes.

This corporation is organized and operated exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

More particularly, the purposes of this Corporation are:

- (a) The purpose of Ministerio Cristiano Nuevo Comienzo Inc, is to honor God by reaching people with the Good News of Jesus Christ and teaching them to become fully devoted followers of Him through any and all means appropriate and possible.
- (b) To employ and discharge ministers of the Gospel, and others, to conduct and carry on divine services at the place of worship of the Corporation, and elsewhere, and to collect and disburse any and all necessary funds for the maintenance of said Corporation and the accomplishment of its purpose within the State of Pennsylvania and elsewhere.
- (c) To handle affairs pertaining to property and other temporal matters as required by the civil authorities.
- (d) To make distributions to organizations that qualify as exempt organizations under Section 501(c) (3) of the Internal Revenue Code of 1986 as amended.
- (e) This Corporation is also organized to promote, encourage, and foster any other similar religious, charitable and educational activities; to accept, hold invest, reinvest and administer any gifts, legacies, bequests, devises, funds and property of any sort or nature, and to use, expend, or donate the income or principal thereof for, and to devote the same to, the foregoing purposes of the Corporation; and to do any and all lawful acts and things which may be necessary, useful, suitable, or proper for the furtherance of accomplishment of the purposes of this Corporation. Provided, however, no act may be performed which would violate Section 501 (c) (3) of the Internal Revenue Code of 1986, as it now exists or as it may hereafter be amended.

ARTICLE VIII: LIMITATIONS

The corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX: DISTRIBUTION UPON DISSOLUTION

The property of this Corporation is irrevocably dedicated to religious purposes meeting the requirements of Section 501(c)(3) of the Internal Revenue Code, and no part of the net income or assets of this Corporation shall ever inure to the benefit of any director, trustee, officer of member of this Corporation, or to the benefit of any individual.

Upon the winding up and dissolution of this Corporation, and after paying and adequately providing for all debts and liabilities of the Corporation, the first of which will be any salaries owed, the assets of this Corporation shall be distributed to local nonprofit religious institutions, which are organized and operated exclusively for religious purposes, and exempt from taxation under Section 501(c)(3) of the Internal Revenue Code; however, if the named recipient(s) is not in existence, or is not a qualified distributee, or is unwilling or unable to accept the distribution, then the assets of this organization shall be distributed to a fund, foundation or organization organized and operated exclusively for the purposes specified in 501(c)(3) of the Internal Revenue Code.
