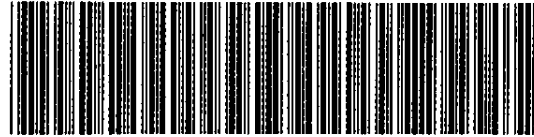

ARTICLE I
NAME OF THE CORPORATION

The name of this corporation shall be Miracle Village Community Church, Inc.

ARTICLE II
ADDRESS OF PRINCIPAL OFFICE

The address of this corporation is 101 Pelican Lake Drive, Pahokee, FL 33476

ARTICLE III
EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE IV
GENERAL NATURE OF BUSINESS

The general nature of the business to be conducted by Miracle Village Community Church, Inc. shall be to provide Christian religious services, Christian charity, and Christian education to the community.

The purposes for which Miracle Village Community Church, Inc. is organized are exclusively religious, charitable, and educational within the meaning of section 501(c)(3) of the Internal revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The powers of Miracle Village Community Church, Inc. are limited to those within the scope of section 501(c)(3) of the internal revenue code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, Miracle Village Community Church, Inc. shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE V
DIRECTORS

The business of the corporation shall be conducted by a Board of Directors which shall consist of not less than three (3) persons as shall be designated by the bylaws, and elected at the annual meeting, or at a specially-called meeting for the purpose of electing a director of this corporation.
