I

II

- A. This organization is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.
- B. The Specific purposes for which this corporation is organized exclusively for charitable purposes, including, relief for the poor through reducing hunger by providing healthy, nutritious food for needy families in the Harlem Heights and surrounding communities in Fort Myers, Florida, treating those who come through our door with dignity and respect.
