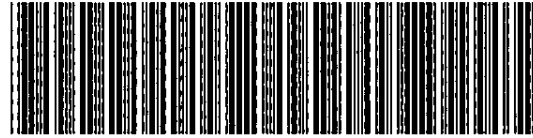

Articles of Incorporation of The Castor-Bell-Lewis Family Foundation, Inc.

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida pursuant to Chapter 617C.F.S., do hereby certify:

First: The name of the Corporation shall be The Castor-Bell-Lewis Family Foundation, Inc.

Second: The place in this state where the principal office of the Corporation is to be located is 3012 Harbor View Ave, Tampa, Hillsborough County, Florida, 33611.

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Fourth: The names and addresses of the persons who are the initial trustees of the corporation are:

William R. Lewis -- President/Director - 3012 Harbor View Ave, Tampa, Florida 33611

Kathy Castor -- Vice President/Director -- 3012 Harbor View Ave, Tampa, Florida 33611

Betty Castor -- Vice President/Director -- 3435 Bayshore Blvd., Apt 1601, Tampa, Florida, 33629

Sam Bell -- Vice President/Director -- 3435 Bayshore Blvd., Apt. 1601, Tampa, Florida 33629

Fifth: The Castor-Bell-Lewis Family Foundation, Inc.'s purpose is community charitable giving. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Sixth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Seventh: The Manner of which the directors are elected and appointed are as per Bylaws.

Eighth: The four initial directors referenced herein each have 25% of the voting shares.

Ninth: The registered agent is William Lewis 3012 Harbor View Ave, Tampa, Florida 33611

Tenth: The Incorporator is William Lewis 3012 Harbor View Ave, Tampa, Florida 33611
