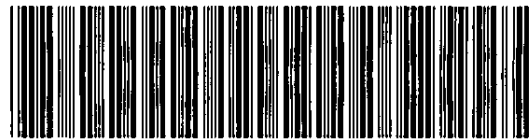

**ARTICLES OF INCORPORATION**  
**OF**  
**VOLUNTEER NURSES FOR WELLNESS, INC.**

The undersigned Incorporator of these Articles of Incorporation is a natural persons competent to contract and hereby forms a corporation under the Florida Not for Profit Corporations Act.

**ARTICLE I. NAME AND PRINCIPAL OFFICE**

The name of this corporation is Volunteer Nurses for Wellness, Inc. and its principal office is located at 2788 Via Baya Lane, Jacksonville, Florida 32223.

**ARTICLE II. DURATION**

This corporation is to exist perpetually.

**ARTICLE III. EXCLUSIVE PURPOSE**

This corporation is organized to promote and support health fair for the purpose of encouraging and assisting persons that need medical care with finding medical resources.

The purpose for which the organization is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law.

**ARTICLE IV. EXCLUSIVE BENEFIT**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustee, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in futherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distributions of statements) any political campaign on behalf of any candidate for public office.

Nothwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under

section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law.

#### ARTICLE V. DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE VI. MEMBERS

The corporation shall initially have one class of members consisting of three members. The initial members shall be Bobbie Cockrell, Kassy Decker and Jane O'Brien. Provisions for additional members and their qualifications shall be set in the bylaws of the corporation.

#### ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 7400 Baymeadows Way, Suite 106, Jacksonville, Florida 32256 and the name of the initial registered agent of this corporation at that address is Robert Wallace. The stockholders shall have the power to establish branch offices, and to move the principal office to any other address in Florida.

A Board of Directors shall consist of three or more individuals with the number fixed in accordance with the bylaws. The initial directors shall be Bobbie Cockrell, Kassy Decker and Jane O'Brien. Directors shall be elected or appointed in the manner and for the terms provided in the bylaws.
