Articles III. The purposes for which the corporation is organized are:

- 1. To operate exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future United States Internal Revenue Code ('Code").
- 2. To do such things and to perform such acts to accomplish its purposes as the Board of Directors may determine to be appropriate and as are not prohibited by Sections 501(c)(3), 509(a)(1) and 170(b)(1)(a)(vi) of the code.
- 3. To otherwise operate exclusively for charitable, scientific or educational purposes within the meaning of Section 501(c)(3) and as a public charity pursuant to Section 509(a)(1) and 170(b)(1)(a)(vi) of the Code in the course of which operation:
 - a. No individual member, if any, or trustee of the Corporation shall have title to or interest in the corporate property or earnings in his or her individual or private capacity and no part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, any trustee, officer, individual member or any private individual except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered:
 - b. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, nor shall the Corporation participate in, or intervene in any political campaign on behalf of (or in opposition to) any candidate for public office;
 - c. Notwithstanding any other provisions of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt for Federal income tax under Section 501(c)(3) of the Code; or (b) by a corporation qualified as a public charity pursuant to Sections 509(a)(1) and 170(b)(1)(a)(vi) of the Code; or (c) by a Corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

Articles IV. The manner in which the directors are elected and appointed:

Prospective Directors are nominated by sitting members of the Board of Directors for a specific term of service. A secret ballot is conducted among the nominated Prospective Directors. In case of a tie, the President shall be authorized to cast a tie-breaking vote.
