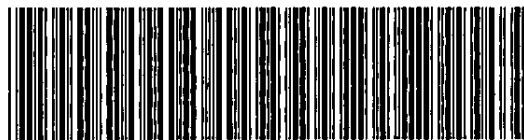

**ARTICLES OF INCORPORATION
FOR
Brevard County Sheriff's Office Pet Posse, Inc.**

ARTICLE I

The name of the Corporation is Brevard County Sheriff's Office Pet Posse, Inc.

ARTICLE II

The initial street and mailing address for the principal place of business of this Corporation is 700 Park Ave., Titusville, FL 32780

ARTICLE III

This Corporation is formed exclusively for charitable, educational, religious and/or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as amended, or under any corresponding provisions of any subsequent federal tax laws governing the distributions to organizations qualified as tax-exempt.

ARTICLE IV

The initial Board of Directors of the Corporation shall consist of three (3) Directors initially. The number of Directors may be either increased or diminished from time to time by the members, but shall never be less than three (3). The manner of electing Directors shall be provided for in the Bylaws of the Corporation.

The officers of the Corporation shall be a president, vice president, secretary and treasurer. The manner of electing officers shall be provided for in the Bylaws of the Corporation.

ARTICLE VII

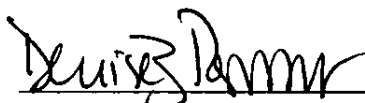
The name and address of the initial incorporator shall be: Denise Postlethweight, 700 Park Ave., Titusville, Florida 32780.
