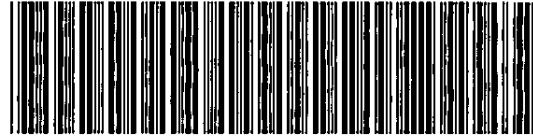

ARTICLES OF INCORPORATION  
OF  
SGI CAT ALLIES-FELINE FRIENDS, INC.

In order to form a corporation under and in accordance with the provision of the State of Florida for the formation of not-for-profit corporations, we, the undersigned, do hereby associate ourselves together as a charitable and educational corporation for the purpose and with the powers hereinafter set forth, and to accomplish that objective we do hereby make, adopt and subscribe these Articles of Incorporation.

ARTICLE I  
NAME OF CORPORATION

The name of the Corporation ("Corporation") is SGI Cat Allies-Feline Friends, Inc.

ARTICLE II  
OFFICE

The street address of the principal office of the Corporation is 234 Prado St., Apalachicola, Florida 32320. The mailing address of the Corporation is P.O. Box 903, Apalachicola, Florida 32329.

ARTICLE III  
PURPOSES

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The specific purpose of this corporation is to humanely promote the welfare of community cats on Saint George Island and in surrounding Franklin County, Florida by instituting a Trap, Neuter, Vaccinate, and Return (TNVR) program to include educating the public, assisting cat colony caretakers, and placing cats in home where possible.

ARTICLE IV  
LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political

campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## ARTICLE V BOARD OF DIRECTORS

The manner in which the directors are elected and appointed shall be stated in the Bylaws. The initial board of directors shall consist of three (3) members. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. The names and street addresses of the persons who will serve on the initial board of directors are:

## ARTICLE VI TERM OF EXISTENCE

The term for which this corporation shall exist shall be perpetual.

## ARTICLE VII DISTRIBUTION UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

## ARTICLE VIII INDEMNIFICATION

The Corporation shall indemnify its directors, officers, employees, and agents to the

fullest extent permitted by law.
