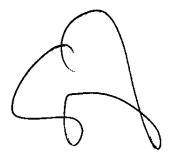

The corporation is organized exclusively for the purpose of receiving and administering funds for charitable, educational and scientific purpose as described in section 501 (C) (3) of the Internal Revenue code by supporting the re-building of communities devastated by natural disaster.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities, or exercise any powers not in furtherance of section 501 (c) (3) purposes.

ARTICLE VIII

Upon dissolution of this organization and after payment of all outstanding debts of the organization, the remaining assets shall be distributed to an organization that has a current 501 (C) (3) determination to be selected by the board of directors.

ARTICLE IX

No part of the net earnings of the corporation shall insure the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III (statement of purpose) hereof. Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (1) by a corporation except from federal income tax under IRC 501 (C) (3) or the corresponding section of any future federal tax code of (2) by a corporation whose contributions are deductible under IRC 170 (C) (2) of the corresponding section of any future tax code.
