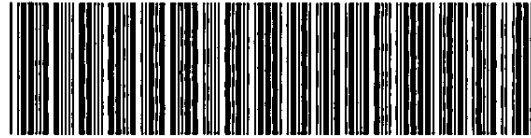

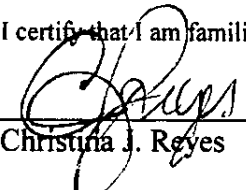

### **Article VIII- Non Discriminatory policy**

The TDR Christian Academy School admits students of any race, color, national and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the school. It does not discriminate on the basis of race, color, national and ethnic origin in administration of its educational policies, admissions policies, scholarship and loan programs, and athletic and other school-administered programs.

### **Article IX- Limitations**

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. .

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.")

### **Article X- Dissolution**

Upon the dissolution of the corporation, any remaining assets after payment or provision for payment of all debt and liabilities of the corporation, assets shall be distributed for one or more exempt purposes to a non-profit corporation, trust, community fund or foundation that has established their tax-exempt status within the meaning of section 501(c)(3) of the Internal Revenue Code. Any such assets not so disposed of shall be disposed of by the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated

exclusively for such purposes.

**Article XI- Amendment:**

This corporation President reserves the right to amend, alter, or repeal any provision set fourth herein, in the manner provided by the by laws and any limitations set fourth by the not for profit laws of the State of Florida.

**Article XII- Management**

The corporation shall be directed by the governing body, which consist of the three initial directors and no more than 12 directors. All final decisions shall be made permanent by the President.
