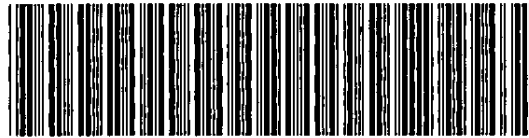

ARTICLES OF INCORPORATION OF
CHRIST COMMUNITY CHURCH OF CITRUS COUNTY, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we the undersigned, residents and citizens of the United States of America, of full age of majority, have for the purpose of forming a not-for-profit religious corporation pursuant to the laws of the State of Florida, for the purposes expressed in ARTICLE III hereof, adopted the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is: **Christ Community Church of Citrus County, Inc.**

ARTICLE II - EFFECTIVE DATE; DURATION

The existence of the corporation shall begin on: **September 9, 2014**. The corporation shall have perpetual existence unless earlier dissolved.

ARTICLE III - PRINCIPAL OFFICE

The street and mailing address of the principal office of the corporation is:

808 W. Dampier St., Inverness, FL 34450

ARTICLE IV - PURPOSES

The specific purpose of this not-for-profit corporation is:

A. To operate for the religious and charitable purposes of a church within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, of the United States of America and any other applicable law;

B. To solicit, receive, administer, and distribute funds to or for the corporation and its purposes or work, or other charitable organizations established for similar purposes as the corporation including, but not limited to, Christian schools;

C. To acquire, own, purchase, lease, hold, occupy, use, enjoy, manage, improve, develop, sell, exchange, transfer, and otherwise deal with real, personal, and intangible property wherever situate either absolutely or in trust to carry out the purposes of the corporation in any State, territory, district, or possession of the United States, or in any foreign country;

D. To do such other things and to perform such other acts to accomplish purposes appropriate and not forbidden by Section 501(c)(3) of the Internal Revenue Code of 1986, with all the power conferred on not-for-profit corporations under the laws of the State of Florida and any other applicable law.

ARTICLE V - SHARES

This not-for-profit corporation is formed without any purpose of pecuniary profit and shall therefore have no capital stock.

ARTICLE VI - DIRECTORS; OFFICERS

The manner in which the directors and officers of the corporation are elected or appointed is provided for in the bylaws. The names and addresses of the persons who will serve as the initial officers of the corporation shall consist of:

ARTICLE VII - BYLAWS AND AMENDMENTS

The corporation shall have the right to make and adopt such bylaws as they deem proper and necessary, and reserves the right to amend or repeal any provisions contained in the bylaws and/or these Articles of Incorporation, or any amendments thereto.

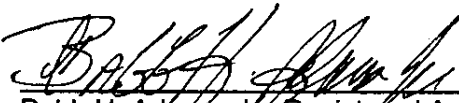
