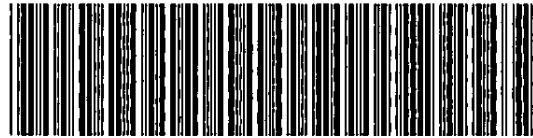

The Florida general corporation Act, adopt the following articles of
Incorporation for such corporation.

ARTICLE I NAME

The name of the corporation is:

ARTICLE II PRINCIPAL OFFICES

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:
Exclusively for charitable, religious, educational, and scientific purposes,
including, for such purposes, the making of distributions to organizations that
qualify as exempt organizations under section 501(c) (3) of the Internal Revenue
Code, or corresponding section of any future federal tax code. To establish and
develop a center for the homeless and provide mentoring and support services to
help them adjust into living a normal life. To provide job training program that
will assist families of Palm Beach County communities.

ARTICLE IV PROVISION

Upon the dissolution of the corporation, the Board of Directors shall, after paying
or making provision for the payment of all of the liabilities of the corporation, shall
dispose of all the assets of the corporation exclusively for the purpose of the
corporation in such manner, or to such organizations organized and operated
exclusively for charitable purposes as shall at the time qualify as an exempt
organization under section 501 (c) (3) of the Internal Revenue Code; as the Board
