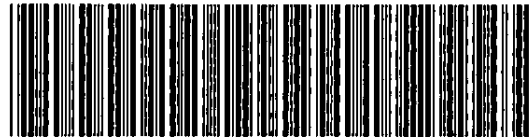

4. Conduct all other powers necessary to carry out the general and specific purposes of the corporation.





