2. To engage the community in activities such as performance, art, and live panels to educate the community to end LGBTQIA+ discrimination.
3. To develop global community leaders who will create spaces free of discrimination where LGBTQIA+ people can engage, learn, grow, and belong.

Said corporation is not organized for profit, and no part of the net earnings of this corporation shall inure the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
