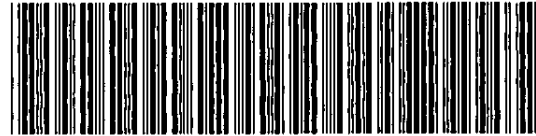

ARTICLE III

Purpose

The specific purposes for which the corporation is organized are:

This corporation is organized exclusively for charitable and educational purposes as specified within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, including for such purposes, the making of distributions to exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

The general purpose of the Godby Softball Boosters, Inc. shall be to promote the welfare and morale of all organized softball teams that represent Godby High School. 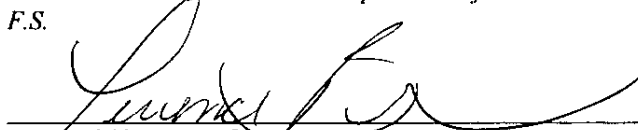

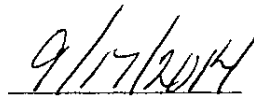
