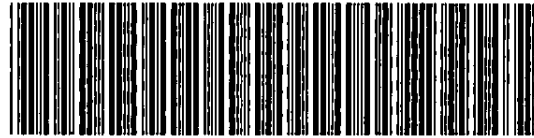

This organization is known as the Greater Thankful Mighty Zion Missionary Baptist Church of Miami Inc. and was organized in August, 2014 and incorporated September 12, 2014.

Article II. Location
