Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

The undersigned, for the purpose of forming a Florida not-for-profit corporation,  
hereby adopts the following Articles of Incorporation:

ARTICLE I – PRINCIPAL OFFICE

The name of the corporation is Higher Calling Int Min Church, Inc. The principal office of the corporation is located at 808 E. Okaloosa Avenue, Tampa, FL 33604. The mailing address of the corporation is P.O. Box 16631, Tampa, FL 33687

ARTICLE II - DURATION

The period of duration of the corporation is perpetual.

ARTICLE III - PURPOSE

The purpose for which this corporation is formed are exclusively religious, charitable and educational, including but not limited to establishing and maintaining ministries that the church may be led of by God to establish.

ARTICLE IV – REGISTERED AGENT

The address of the registered agent of the corporation is 10911 N. 28<sup>th</sup> Street, Tampa, Florida 33612. The registered agent at this address is Darren Jones.

ARTICLE V – BOARD OF DIRECTORS

The method of election of the board of directors shall be spelled out in the bylaws.

#### ARTICLE VI - LOBBYING

No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in any political campaign on behalf of any candidate for political office.

#### ARTICLE VII - DISSOLUTION

At the time of dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, dispose of all of the assets of the corporation. The assets of the corporation shall first be distributed to an organization recognized as exempt under section 501c3 of the Internal Revenue Code to be used exclusively for charitable and educational purposes. If the corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the corporation's principal office is located.

#### ARTICLE VII – PERSONAL LIABILITY

No Director, Officer, or member of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the (members) officer, or Directors be subject to the payment of the debts or obligations of this corporation.


