

#### ARTICLES OF INCORPORATION

#### Empower 1st, Inc.

The undersigned, being of legal age and competent to contract, for the purpose of organizing a non-profit corporation pursuant to the laws of the State of Florida, do hereby state the Articles of Incorporation of Empower 1st, Inc., in their entirety, and adopt the following Articles of Incorporation and agree and certify as follows:

#### ARTICLE I NAME

Empower 1st, Inc. ETN: 41-186,7983 (Hereinafter a non-profit corporation)

## ARTICLE II PRINCIPAL PLACE OF BUSINESS

The principal place of business for this corporation is at 1040 Willow Drive, Leesburg, F1 34748

The property and assets of this corporation are irrevocably dedicated to Charitable, Religious, Educational and Literary purposes.

# ARTICLE III PURPOSE

The purpose of Empower 1st is established to provide assistance to disadvantaged citizens of Floridavin every way possible and equip them to be better for themselves, their families and their community. The organization is organized exclusively for charitable, religious, educational and literary purposes under the Internal Revenue Code section 501(c) (3).

Empower 1st, Inc. shall do all lawful activities which may be necessary, useful or desirable for the furtherance, accomplishment, fostering or attaining of the aforementioned purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, associations, trusts, institutions, foundations or governmental bureaus, departments or agencies.

Notwithstanding, any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under Section 501c3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code.

The Corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The Corporation shall not distribute any gains, profits or dividends to the Directors, Officers or Members thereof, or to any individual except as reasonable compensation for services actually performed in carrying out the Corporation's Charitable and educational purposes. The property, assets, profits and net income of the corporation are irrevocably dedicated to charitable, literary and educational purposes, and no part which shall inure to the benefit of an individual.

No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

#### ARTICLE IV MEMBERSHIP

There is no membership in this organization.

### ARTICLE IX DISSOLUTION


