ARTICLES OF INCORPORATION

THE LUCIAN CONDOMINIUM ASSOCIATION, INC.

The undersigned incorporator, forms this corporation not for profit pursuant to the laws of the State of Florida, and adopts the following articles of incorporation:

ARTICLE 1. NAME. The name of this corporation is THE LUCIAN CONDOMINIUM ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "Association," these articles of incorporation as the "Articles," and the bylaws of the Association as the "Bylaws."

ARTICLE 2. TERM OF EXISTENCE. The Association shall have perpetual existence.

ARTICLE 3. PURPOSE. This Association is organized for the purpose of providing an entity under the Florida Condominium Act (the "Act") for the operation of a condominium located in Walton County, Florida and known as The Lucian, a Condominium (the "Condominium"), created pursuant to the Declaration of Condominium (the "Declaration").

ARTICLE 4. MEMBERS. The qualification of members shall be contained in the Bylaws.

ARTICLE 5. INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT. The street address of the initial principal office and mailing address of this corporation is 9581 County Highway 30A East, Panama City Beach, Florida 32413. The registered office of the Association is 1200 South Pine Island Road, Plantation, FL 33324 and the name of the initial registered agent at that address is NRAI Services, Inc.

ARTICLE 6. BOARD OF ADMINISTRATION. The day to day affairs of the corporation shall be managed by the Board of Administration and the manner in which the members of the Board of Administration shall be elected or appointed shall be contained in the Bylaws.
