MISSION STATEMENT: No Veteran shall be left to fight Post Traumatic Stress Disorder (PTSD) and or Traumatic Brain Injury alone; our commitment is helping Veterans and their families to heal their emotional wounds, in order to prevent suicide. We approach this treatment via interactive peer groups that support and encourage the use of personal resources, thus helping to make lifelong changes that occur in perception, in order for the wounded service men and women to live the healthiest life possible.

CREATED:

Peace and Life for Veterans was established in 2014 for Veterans, in order to help resolve life altering issues surrounding PTSD, TBI, which also affects the entire family structure as well. In addition, we will also be providing existing C.E.U. approved & designed training programs for Mental Health Professionals, Veterans and any family members who wish to participate in our programs.

Peace and Life for Veterans, Inc. sole's purpose is as a charitable organization to lessen the distress of our Veterans and help relieve their suffering from the trials of war and conflict.

PEACE AND LIFE FOR VETERANS VISION:

Inspire Veterans to participate in their own healing, to help grow beyond their self-imposed limitations. Our core objective is to help the Veteran to use their own strengths and personal resources to achieve positive results in their lives as well as with their families, thus fostering an easier and less stressful reintegration.

Our commitment is to help individuals make wise choices and decisions in their personal and professional lives, for each individual to take responsibility for his/her own actions, and help give back to their families, community and brothers and sisters in arms.

In addition, we will be establishing an educational peer support guidance program, that will be run by the Veterans themselves, with an emphasis on soldier-to-soldier mentoring coupled with helping to create future jobs and implementing long term occupational and vocational goals...
