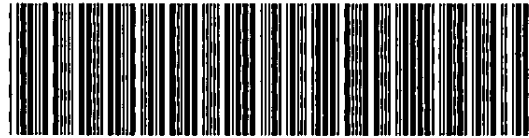

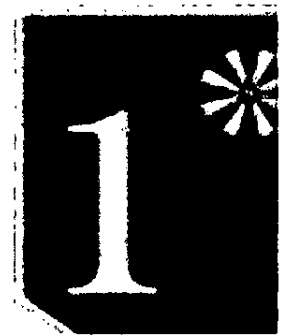

ARTICLE I: NAME

The name of the corporation shall be:

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE

The purpose for which the corporation is organized:


