Article I Name

The name of the corporation shall be: K9 Veterans Memorial Foundation, Inc.

Article III Purpose

The corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The corporation is organized to recognize the role of, and contributions of, K9 dogs to the United States Military, Police Organizations, and other related service organizations. The corporation is organized to raise funds to assist relevant organizations in ways, selected then, to provide aide in possibly obtaining and training service dogs. Other contributions may include equipment for various K9 Units.

Article IV Manner of Election
