Articles of Incorporation

of

#teachHope, Inc.

(A Corporation Not For Profit)



The undersigned, acting as incorporator of #teachHope, Inc. under the Florida Not for Profit Corporation Act (Chapter 617, F.S.) adopts the following articles of incorporation:

Article I - Name

The name of the corporation shall be #teachHope, Inc. (hereafter, the "Corporation").

Article II - Principal Office/Mailing Address

The principal office and mailing address of the corporation is 240 NW 121 Court, Miami, FL 33182.

Article III - Duration

The duration of the corporation is perpetual, unless sooner dissolved by the officers or shareholders as provided for by the laws of Florida.

Article IV - Purpose

The mission of #teachHope, Inc. is to encourage kids to help and care for the less fortunate in their community. The project is simple – show kids examples of kindness then teach them how they can do the same.

#teachHope, Inc. believes that the best way to instill in children the motivation to help others by encouraging them and providing useful avenues that allow them to make a difference. Parents, friends, and teachers simply need to help them tap into their desire to help.

The Corporation is organized and shall operate exclusively for cultural, charitable and educational purposes of conducting or supporting activities for the benefit of or to carry out the purposed of #teachHope, Inc. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The Corporation may engage in only such activities permitted under the laws of the State of Florida and the United States of America as shall constitute activities in furtherance of such exempt purposes.

No substantial part of the activities of the Corporation shall be the carrying on the propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Article V - Dedication and Distribution of Assets

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to charitable organizations which would then qualify under Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.
