Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: For the advancement and research of ADAPTIVE athletes in sports and competition, while creating a global community where research of the benefits of exercise for ADAPTIVE athletes can be explored.
