CERTIFICATE OF INCORPORATION

of

(Pursuant to Article 10 of the Religious Corporation Law)

WE, the undersigned, all being persons of full age, of whom at least two-thirds are citizens of the United States, and at least one a resident of the State of St. Lucie, Florida, 34984

for the purposes of incorporating an unincorporated church, pursuant to Article 10 of the Religious Corporation Law, hereby certify as follows:

FIRST: A meeting of, an unincorporated Church was duly called and held in conformity with the aforesaid Article 10 of the Religious Corporation Law

on the 23<sup>rd</sup> day of May, 2012, Port St. Lucie, Florida, 34984, at which a meeting of majority of the duly qualified Trustees of said organization, being at least six in number were present.

SECOND: At said meeting BISHOP one of the subscribers Hereto was presiding officer, the others Rev. Faye Jones. and Minister Mavis Scott, subscribers hereto were Trustees of the election.

THIRD: At said meeting, it was duly decided that the said Organization should be incorporated.

FOURTH: The name of the organization **CHERUB APOSTOLIC CHURCH OF GOD, INC.**

*FIFTH: That the particular objects or purpose for which said Corporation is formed are as follows: to wit:-*

- a) To maintain a place of worship for all individuals that desire to fulfill the word of God.*
- b) To propagate the Gospel of Jesus Christ throughout the world.*
- c) To initiate a Bible school, teaching the fundamental of the bible to all ages.*
- d) To visit hospitals, nursing homes, shelters, prisons, and other institutions.*
- e) To promote the Word of God through the teaching of the Bible in order to expand and*
- f) To ORDAIN Bishops, Elders, Ministers, Evangelists, Deacons, Missionaries, and other officers accordingly to the ordinances of the church.*
- g) To teach, counsel, instruct youths and encourage youth activities and trips.*
- h) To become involved in Radio, TV, seminars, workshops, conferences to win souls for Christ.*
- i) To established churches in other countries under Cherub Apostolic Church of God, Inc. overseas and abroad under the headquarter church.*
- j) To perform RITUALS: such as Marriage accordingly to the State of Florida. License Law and to conduct communion, christenings, baptisms and funerals as per request and Dedication of Babies, accordingly to the church's ordinances.*
- k) To initiate a day care, elderly, youth and adult centers and provide food, clothing and other outreach activities to meet the needs of the community.*
- l) To rent, lease or purchase such buildings or edifices which might be needed by the congregation under the State of Florida.*
- m) To buy, vacant land or buildings, alter, develop, build or repair same for the use of the corporation, and to dispose of same when no longer needed under State of Florida.*
- n) To purchase, accept, acquire wholly or in part, and to any lawful use or purpose, and for and upon lawful consideration mortgage and other similar instruments, and any and all rights there under and property therein, also and likewise and in like manner, bonds, obligations, debentures, notes, certificates, of interest, stocks and receipts created by any corporation or corporations, syndicates, individuals, governments, states municipalities or political or governmental division or agencies and all rights and coerce under the same or any of the same under the State of Florida.*
- o) To borrow money and to contract debt when necessary for the exercise of its corporate rights, privileges, or for any other lawful purposes of its obligations for any amount so borrowed; to mortgage its property and or to make such deed of trust as may be necessary to secure the payment of such obligations or of any debts contracted for such purpose under the State of Florida*
- p) To have power to take and hold any grant, donation, gift, bequest or devise of real or personal property and to have the power to solicit and raise funds by any and all proper and appropriate means, under and subject to the Religious Corporation Law, and to receive and disburse such funds or money accruing from tithes, offerings, collections or any other contribution for the general support of said Corporation under the State of Florida.*
- q) To enter, into, make, perform, and carry out contracts with any persons, firm, corporation, private, public, municipal or political body under the government of the United States of America and foreign countries, so far and to the extent that the same may be done and performed under the provisions of the Religious corporation Law of the State of Florida.*

SIXTH: The foregoing clauses shall be construed both as subjects and powers, and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be construed or held in limit or restrict in any manner the powers of the within Corporation.

SEVENTH: The number of Trustees thereof shall be (6) six.

EIGHTH: The first annual election of the Trustees shall be held on the 4th day of January 2013 and the annual election of Trustees shall convene each year thereafter. The determine date for the election of Trustees shall be not more than fifteen months thereafter, March 4, 2014 on which the annual election of Trustees shall continue thereafter such meeting shall be held.

NINTH: The names of the persons elected as TRUSTEES and the TERMS OF OFFICE for which they were respectively elected are as follows:

BISHOP MICHAEL SCOTT residing at 286 S. W. ESSEX DRIVE, PORT ST. LUCIE, FLA. 34984, and REV. FAYE JONES, 1352 Rogers Avenue, Brooklyn, N.Y. 11226 - to hold office until the FIRST ANNUAL ELECTION of Trustees and DEACON ATHON JOHNSON, residing at 1202 SW, Wellington Avenue Port St. Lucie, Fla. 34953, MINISTER MAVIS SCOTT, residing at 286 S.W. ESSEX DRIVE PORT ST. LUCIE, FLA. 34984. to hold office until the SECOND ANNUAL ELECTION of Trustees thereafter, and JOSETT GRUBBS, residing at 386 East 18<sup>th</sup> Street, Brooklyn, 11226 and PAMELLA DENEVLAUS, residing at 6175 N. W. 57<sup>th</sup> Street, TAMARAC, FLA. 33319 to hold office until the THIRD ANNUAL ELECTION of Trustees thereafter.

TENTH: The principal place of worship is located at 286 Essex Drive, Port St. Lucie, Florida, 34984.

**ELEVENTH:**

*Said organization is organized exclusively for charitable, religious, education and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organization under section 501(c)(3) of the International Revenue Code, or corresponding section of any future federal tax code.*

**TWELFTH:**

*No part of the net earning of the corporation shall inure to the benefit of, or be distributable to the directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 10 thereof.*

**THIRTEENTH:**

*No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.*

**FOURTEENTH:**

*Notwithstanding any other provision of the document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) International Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contribution to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.*

**FIFTEENTH:**

*Upon the of dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the County in which Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organization, as said Court shall determine which are organized and operated exclusively for such purposes.*

SIXTEENTH: That no other application has been made, filed or recorded for the above Certificate of Incorporation of a Religious Corporation.

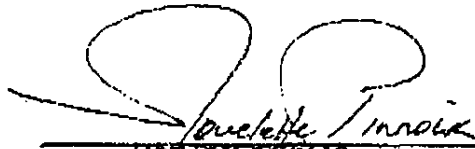

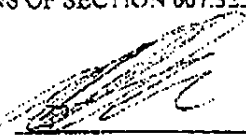
